DECISION NO. 14/2022 ON PREVENTION OF THE SPREAD OF COVID-19 DISEASE CAUSED BY THE NEW SARS-COV-2 CORONAVIRUS AT BUT

Article 1

Specific legal regulations and measures of public administration bodies

BUT follows current legal regulations and measures of the Ministry of Health and other public administration bodies issued in connection with the need to prevent the spread of COVID-19.

Article 2

Rules for entering BUT buildings and staying in common areas of BUT buildings

1. It is strictly forbidden for staff, students and other persons with symptoms of a cold or viral infectious disease (e.g. a runny nose, fever, cough, shortness of breath, sudden loss of taste and smell, etc.) to enter the BUT buildings.
2. Staff, students and other persons on the premises of BUT are obliged to disinfect their hands when entering the buildings, after using the toilets and before entering the classrooms and libraries. Necessary and appropriate hand sanitizers will be provided by the appropriate BUT unit.
3. During the period of increased incidence of viral diseases, respiratory protection is recommended in common areas or classrooms.

Article 3

Measures to prevent the spread of COVID-19 in full-time study

Students with symptoms of a viral infectious disease shall excuse their absence from full-time study in a standard way applicable to the faculty or institute of higher education.

Article 4

Halls of Residence and Dining Services

1. Persons with symptoms of a viral infectious disease are expressly prohibited from entering the catering facilities of the Halls of Residence and Dining Services of BUT.

2. When entering the catering facilities of the Halls of Residence and Dining Services of BUT, everyone is obliged to disinfect their hands using a hand sanitizer placed at the entrance to the catering facility.

3. Persons accommodated in the BUT halls of residence are obliged to immediately report a positive result of the RT-PCR test for the presence of SARS-CoV-2 virus or a positive result of the test for the presence of SARS-CoV-2 antigen, including a self-test, to karantena@vutbr.cz. They are also obliged to immediately report the fact that isolation due to COVID-19 has been ordered for them.

4. The reports under Article 4(3) hereof will be the basis for taking appropriate anti-epidemic measures to prevent the spread of COVID-19 in the BUT halls of residence (placing sick persons or persons with symptoms of a viral infectious disease in isolation rooms, etc.). Persons accommodated in the halls of residence are obliged to follow instructions aimed at prevention of the spread of the disease issued by the staff of the Halls of Residence and Dining Services of BUT.

5. In the BUT halls of residence (all buildings) it is forbidden to visit the residents for whom isolation due to COVID-19 has been ordered.

Article 5 Institutional measures and senior staff responsibilities

Taking into account the current epidemiological situation, senior staff at all levels of management are obliged to continuously monitor and evaluate the possible spread of SARS-CoV-2 infection among staff at the workplace under their management and to implement specific measures, including:

- a) possible restriction of public access to the premises or buildings,
- b) possible restriction of contact between persons (also using work from home in the cases of symptoms of a viral infectious disease or in the cases of proven COVID-19 infection),
- c) possible adaptation of operation of long- and short-term tenants and any events they organise.

Article 7 Final Provisions

1. This internal standard repeals Rector's Decision No. 6/2022 issued in relation to the development of the emergency situation in the spread of COVID-19 disease caused by the new SARS-COV-2 coronavirus.

2. This internal standard becomes effective on the date specified in its heading.
